The Medical Superintendent cum Vice Principal of Diamond Harbour Government Medical College and Hospital having its office at New Town, Ward No 4, Diamond Harbour, South 24 Parganas is inviting quotation on behalf of the Dept. of H&FW, Govt. of West Bengal for obtaining the rate of Pest Control for the period February 2021 to January 2022 and Anti Termite Treatment for old hospital building, DHGMC&H.

Time Schedules for the Tender:

- Last Date of Submission of Quotation is 15.02.2021, 12.00 noon.
- Date of Opening Quotation is 15.02.2021, 2.00 p.m.

Terms & Conditions:-

1. The quotation should be submitted in schedule envelope and prescribed format with the name written on it.
2. Payment will be done on monthly basis subject to availability of respective funds.
3. Quotation must be submitted in prescribed format.
4. Rate of Pest control should be quoted for per month and rate of Anti Termite should be quoted for per square feet.
5. Pest control will be done at each room of old hospital building (approx. 1,50,000 sqft.) DHGMC&H on monthly basis and when as required.
6. Anti-Termite Treatment will be done on old hospital building (approx. 70,000sqft) one time with 5 years warranty. Rate for the same should be quoted accordingly.
7. Rate cannot be changed during the total tenure of this tender
8. This Tender Process will be valid from February 2021 to January 2022 subject to satisfactory service.
9. If any bidder fails to submit the required hard copy of any document sought for after opening the bid (submitted offline along with bid), His/ her bid may be consider cancelled.
