OTHER TERMS AND CONDITIONS:

1. The earnest Money Deposited:
 - a. Can be converted into a security deposit against selected bidder. The EMD will be returned to the non-selected bidder within 15 days after opening of financial bid.
 - b. Forfeiture of EMD will be done:
 - i) If the bidder withdraws tender after opening or acceptance.
 - ii) If the selected bidder fails to accept work order, refuses whether wholly or partly the offer that would be made by the undersigned.
 - iii) If the selected bidder fails to do the work or supply material as per specifications.
2. Income Tax and other mandatory tax deduction shall be done as per government norms before payment.
