**WORK COMPLETION PERIOD:** The selected bidder completes his supply within 30 days from the date of issuing supply order.

**OTHER TERMS AND CONDITIONS:**

a. Can be converted into a security deposit against selected bidder. The EMD will be returned to the non selected bidder within 15 days after opening of financial bid.
