No. <u>27083(W)</u> of 2014 praying to consider disbursing and/or making payment of Rs. 1,96,000/- to each of the petitioners under Patharpratima Block within the District of South 24 Parganas for construction of their new dwelling houses from the new housing scheme "Gitanjali" and to act in accordance with law</p> <p>And</p> <p>Whereas against such writ petition, the Hon'ble Justice Patherya has delivered her Judgement on 25.09.2014 as follows :</p> <p>"Now considering the fact and circumstances of the instant case this writ petition is disposed of with a direction upon the District Magistrate South 24 Parganas being the respondent no. 5 is directed to enquire and ascertain whether the writ petitioners herein will be entitled to the benefit of Geetanjali Scheme as propounded to grant relief to those persons whose dwelling houses were destroyed by AILA in 2009. In the event the writ petitioners are found entitled to benefit under the said Scheme, the respondent no. 5 will ensure that necessary directions are issued by the concerned authority in the said area. The eligibility of the writ petitioners to the said Scheme be decided by the respondent no. 5 preferably within a period of Six weeks from the date of receipt of this order."</p>	



Perused the enquiry report along with photographs of the petitioners houses and considering all other aspects of the petitioners and as per the solemn order dated 25.09.2014 passed by the Hon'ble Justice Patherya, it is found that 58 petitioners have already been granted compensation from AILA Relief Fund and remaining 22 petitioners were not affected by AILA.

In the view of the above facts and circumstances relief prayed by the petitioners cannot be considered as they are not eligible.

Therefore their prayer is considered, enquired and rejected and thus the matter is disposed of.
